Mandatory Reporting by Early Childhood Education & Care Professionals

From 1 July 2017, early childhood education and care (ECEC) professionals will be mandated by law to report child safety concerns to the department, where there is a reasonable suspicion that the child has suffered, is suffering, or is at unacceptable risk of suffering, significant harm caused by physical or sexual abuse, and there is not a parent willing and able to protect the child from harm. ECEC professionals include staff from family day care, kindergarten, long day care and after-school hours care. WFDC is undertaking the workshops by NAPCAN (National Association for the Prevention of Child Abuse and Neglect) to deliver training and information sessions for the our service.
